# SONOMA-MARIN PARTNERSHIP HIGH-EFFICIENCY CLOTHES WASHER WATER REBATE APPLICATION

Water Retailers throughout Northern Marin and Sonoma Counties will offer water rebates for Residential High-Efficiency Clothes Washers. This program only rebates High-Efficiency Clothes Washers on the EnergyStar Most Efficient List. For a list of qualifying clothes washers, visit the EnergyStar website: [www.energystar.gov](http://www.energystar.gov) Not all EnergyStar models qualify so be sure to check the list.

## FOUR EASY STEPS TO PARTICIPATE

- 1** Be a customer of one of the Participating Water Retailers identified on this application.
- 2** View the current list of approved clothes washers by visiting your local Water Retailer's website or by asking a sales associate for a copy of the list. *No water rebates will be given for the purchase of clothes washers that use silver ion technology.*
- 3** Purchase a new, high-efficiency clothes washer that meets the specifications described above and have it installed in the service area of one of the participating Water Retailers. Purchase of the clothes washer must have occurred between January 1, 2016 and December 31, 2016 to be eligible for this rebate.
- 4** Submit a completed application and the **sales receipt** by mail to the address of your participating Water Retailer. Please note: *all rebate applications must be postmarked no later than 60 days after purchase date.*



## TERMS AND DETAILS

**Not all EnergyStar models qualify.** Only clothes washers listed on the EnergyStar Most Efficient High-Efficiency Clothes Washer list qualify for this rebate. All rebate applications must be mailed to the proper Water Retailer. Note the rebate amount varies by Water Retailer. Please call the telephone number or visit the website listed on the other side of this application to learn more about the rebates available to you. This application is separate from any other rebate applications from the manufacturer and/or energy provider. The rebates are available until all funds have been spent or December 31, 2016, whichever comes first. This program is subject to change or end without prior notice. The qualifying clothes washer must remain on-site for at least 6 months. There is a limit of one clothes washer rebate per household for every 5 years. Allow up to eight weeks for processing, handling and issuance of rebate.
